Terms and conditions of Academy requirements 1. Minimum requirements

- a) The Academy should have a physical address where it operates from;
- b) An appropriate training venue with ablution facilities should be present;
- c) A register of members of the Academy including gender and age groups in line with 2 (b) below;
- d) Coaching qualification of the Academy coaches or relevant coaching experience.

2. Obligation of Academy

The Academy shall:

- a) Pay the annual registration fee;
- b) Shall avail its database to the NVF;
- c) Comply with all reasonable instructions given by NVF in relation to the conduct of its operations;
- d) Not use or allow others to use the Academy for any improper, immoral or unlawful purpose;
- e) The Academy shall be liable for payment of monthly rental fee of venues where it operates from if such venues are rented;
- f) Unless otherwise specified, the Academy shall comply with the Constitution, Sports Regulations, Child Protection Code of Ethic and Code of Conduct of NVF.
- g) Shall not cede, assign, transfer, encumber or delegate any of its rights or obligations in terms of this registration to any third party without acquiring NVF's consent;
- h) The Academy shall furnish the NVF with a monthly report supported by pictures.

3. Obligation of NVF

The NVF shall:

- a) Support the Academy in its endeavour to develop the young talent through the NVF Development Programs;
- b) Assist the Academy with necessary equipment when available;
- c) Support the Academy in seeking financial support under the NVF banner if such funds are intended for a good purpose;
- d) Support the Academy when such an Academy wish to participate in international volleyball events.
- e) The NVF shall may use the academy pictures and videos on all its social media platforms with intention of marketing the country wide development programs.
- f) The NVF Development Department shall inspect the activities of the academy to measure the strength of the development programs with/ without prior notice.

4. Duration of the recognition

a) The recognition shall commence on the Date of Recognition Agreement Certificate issue and shall endure for the period of 12 months unless terminated by either party giving to the other not less than 30 (thirty) days written notice of termination.

5. Suspension and/or Termination of recognition

- a) A thirty (30) day written notice shall be given to the Academy of NVF's intent to withdraw the Recognition Agreement Certificate.
- b) In the event the recognition has been terminated, all properties belonging to NVF if any, shall be returned to NVF. The academy may not under any circumstance make use of NVF emblem/logo in any of its dealings.
- c) Should the Academy fail to pay its annual affiliation fee in terms of NVF Sports Regulation, NVF shall terminate the recognition agreement in accordance with (a).
- d) NVF may terminate the Recognition Agreement in terms of (a) should it be found that the Academy is in breach of any of the NVF's legal instrument.

6. Liability

- a) The academy shall take full responsibility of its activities and related risks and such risks shall not to be passed to NVF unless such risk occurs as a result of NVF instruction;
- b) The Academy indemnifies NVF against any damages, cost or liability arising from any illness or personal injuries suffered while in the care of the Academy unless stipulated;
- c) NVF shall not be liable for any payment or legal cost imposed on the Academy for whatever reason no matter when or how, arising out of the provision of the Services or otherwise whether direct or indirect, consequential or contingent or whether foreseeable or not and in particular not be liable for the financial loss or loss of profits, contract and or saving.
